# **Privacy Policy**

Akwaaba African Drumming, Art and Craft ("us", "we", or "our") operates the https://www.akwaaba.com.au/ website (hereinafter referred to as the "Service").

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with

## **Definitions**

#### Service

Service is the https://www.akwaaba.com.au/website operated by Akwaaba African Drumming, Art and Craft

#### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and

other information either in our possession or likely to come into our possession).

#### Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

Cookies are small files stored on your device (computer or mobile device).

# Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

## **Types of Data Collected**

#### **Personal Data**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

Akwaaba African Drumming, Art and Craft will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

# Disclosure for Law Enforcement
